5. Neglecting prayers - You forget to pray at the beginning and ending of every chapter. Praying at the beginning and ending of each chapter will help you take in more from what you read.
6. Reading prayer topics - Reading the prayer topics at the end of this book just like ordinary words will result in losing the benefit of it all.
7. Reading the book only once - You are advised to read this book several times and discuss it with somebody that may have similar challenges.

## **Introduction**

All over the world the problem of spirit husband/wife is known. But in most cases it is glorified with a friendly coloration. Movies like “Hercules” and “Randal and Hopkake” show human national heroes relating with spirits from the sea and dead relations in colorful romance; we also entertain our children with these movies and cartoons showing elves and fairies falling in love with Peter Pan and Snow-white. In African traditional religions gods once married young ladies who lived in the shrines; these ladies have supernatural powers that enable them to tell the future. Up to date Voodoo priestesses still serve demons with their virginity. Any man who sleeps with such women will die within hours. Bible also tells of sons of God marrying the sons of men. Occult societies help people get in touch with spirit beings that demand sexual relationships in return for favor.

That is as much as we can see from the outside. But behind the scene men and women are living in bondage to demons who claim to be spouses to humans. These demons that come in as friends and lovers soon begin to make the lives of their captives miserable. In most cases, the victims don't know how to fight back; some return to the agents of these demons to ask for settlement. But their agents are also victims to their whims.

These glorified spirit friends and lovers are what some people are suffering from as spirit husband/wife. These spirits are actually demons (evil spirits); they bare their fangs when their friends decide to change their ways of life. The result is that these friends suffer immensely and have to pay great price for their freedom- if they ever get one.

This book is written to assist those seeking for deliverance from these evil spirits. The first time I published this book, I was surprised at the attention it got and some testified to deliverance from these evil forces. This is the second and enlarged edition. My prayer is that this edition will help more people. I tried in every way I can to make this book practical.

Deliverance from spirit husband/wife is possible through the power and authority in the name of Jesus Christ.

## **Chapter one**

Spirit husband/wife plagues believers and unbelievers; Pastors and members alike. Many Pastors are harassed sexually in their dream on regular bases. Many believing women have this problem. The sufferers of this menace feel polluted and defiled after every such dream. These spirits manifest by trying to control every area of their victims' lives- relationship, businesses, careers, health etc. Spirit husband/wife is a stubborn case and I hope to start with these testimonies to bring more light.

### **TESTIMONIES:**

Brother Ben (not real name) grew up like any other young man with an unbeliever father. His mother had died while they were very young. While he was 35years his father died, and as their firstborn son he played very active roles in his burial. After two months of the burial, he saw a woman in his dream who introduced herself as his father's spirit wife. She said she was very rich and could help anybody who would submit to her. She told Ben that since his father has died, that he (Ben) will have to take his place as her husband. He was to reactivate the shrine his father had erected for her and make sacrifices to her on that altar.

Ben objected on two grounds. His father was poor all his life. How can this supposing rich woman hold any hope for him? Secondly, something inside of him said a total "NO" to the proposal. The woman tried to appeal to him but he will not be moved. The woman turned her back and disappeared and Ben awoke from sleep.

This woman kept visiting Ben in his dreams for close to six months at intervals of days but Ben would not be moved. One day she took Ben to her home that was inside the ocean. Ben did not know how he obeyed her. She showed him a lot of beautiful things; cars, houses, jewels and many wonderful things that a man would desire but Ben still said "No". She sent some strange creatures to torment Ben with things that looked like pinches and scissors. Ben was unyielding.

When she saw Ben could not be moved, she left him, telling him she will make sure he never amounted to anything in life unless he accepted to marry her. He woke up from sleep. As at the time Ben was talking to me, he was forty-two years, and everything he tried failed. Any person who tried to help him eventually had serious problems that discouraged him.

Sister Regal (not real name) was the beautiful wife of a police man. Though married with children, a man in the neighborhood kept pestering her for sex until she gave in to him. And her problem started. Anytime she would want to stay near her husband, this man she had slept with physically would appear

as a spirit being to stand between them. If her husband asked for a cup of water, this spirit being would knock the cup out of her hand. Every night this spirit would come and have sex with her. The thing began to worry her. Somebody introduced this woman to our ministry. I prayed for her and for about two months the spirit person did not visit and I told her to confess to her husband, so that he can forgive her. She refused and this spirit came back and her mother took her to the village. I heard her case is getting worse daily.

Brother Gender (not real name) is a family friend whom we have been trying to lead to the Lord. He came to our Miracle Service captioned “Just a Night in God’s Presence” and related a terrifying story. He had followed a girl to her house hoping to pass the night with her. The girl, a beautiful girl had tried to dissuade him but he was adamant. On that night he noticed the girl making movements that suggested she was having sex with somebody else. He acted as if he was sleeping but was watching. After everything, she told him that she had a spirit husband and that was why she could not keep any relationship with a man. She would want to marry but this spirit man would frustrate any such move.

The case of my wife is a long one but I will try to be brief. I met her as a believer and an intercessor in her church and the evangelistic ministry headed by Dr. B.C. Mbata of the Total Care Ministries. The prayer teams we belonged to confirmed that we were made for each other. Before now there was no trace she had a spirit husband. Just after she accepted my proposal, she began to see me in the dream having sex with so many women at the same time. At other times she would see me revealed to her that I will not make it in ministry. Because of this she withdrew as she did not want to marry against God’s will.

She went to a Night Vigil and a man of God who neither knew her nor me nor have heard our story, told her to return to me as I was God’s man for her, identifying what she saw as a familiar spirit husband. She came back but crisis started from all over; from her parents’ side, her church, and fellowship. It was trouble all over. Space will fail me to tell all we went through before we wedded.

After our wedding a woman appeared to her in the dream and asked her why she chose to submit to a man rather than to her. My wife told her I was her rightful husband and she was right to submit to me.

The bulk of this story I leave for a bigger book but if not for God’s mercy she would have died on her first delivery. There was a time she was so sick I prayed to God to take her and allow her soul find rest in him. Thank God she is okay today and serving God with me.

## **Chapter two**

### **WHAT IS SPIRIT HUSBAND/WIFE?**

The stories we have told earlier would have given you the definition. They are spirit beings trying to find expression into physical lives. They are fallen angels who have perverted themselves. These demons get into marriage contract with humans, and would want to keep them from having normal marital relationships. The way they secure these ungodly marriage contracts we shall see later.

This is part of Satan's program to mess-up God's creation. They are evil as such a relationship between man and spirit is pervasive. Many of them demand worship. Like Mummy-water or Queen of the Coast. Some traditional deities also marry humans who they leave as shrine prostitutes. Some women married to such deities are free to go out with but cannot marry another man. Some men who have such problem cannot have sex with other women, not because they are impotent but that evil spirit won't let them.

Most men and women in this bondage are very attractive. There are some who do not know they are into it, like my wife. She was actually seeded to this spirit as a baby. The spirit could not have its way because she gave her life to Christ and lived a chaste life. They only got very provoked when she tried to marry.

### **HOW DOES ONE GET MARRIED SPIRITUALLY?**

Like in the case of Brother Ben it was transferred. His father for a reason best known to him went to have marriage covenant with Mummy-water and when he died, Mummy-water who now claims to be his family protector chose his son. You will be quick to condemn his father if you do not know that devil is a master deceiver. At times somebody goes to a Mummy-water agent with a problem only for the spirit to say that she will help only if you promise to marry her. Because that person is under pressure, he accepts. Devil and his demons are full of lies (John 8: 44). After you have gone into such covenant you discover they do not fulfill their part. Because they are stronger, you cannot fight. That is how that person comes into bondage.

In some cases a woman in need of fruit of the womb goes to a native doctor or demons' agent; the couples are asked to promise that the child will belong to the spirit. If they accept, they are asked to make a vow. As the woman gets

pregnant and bears the child, the evil spirit sees the child as its property. As that child grows up, he/she discovers he/she has a spirit husband or wife.

In another case, there is what is called baptism of demons. This is one of devil's ways of running down men of God. The bible says that if two persons have sex, they become one spiritually (1 Cor.6: 16). Some people you see on the street are demons incarnate; having sex with such person will grant the demons access to your soul. That was what happened in the case of Regal. The man she slept with was a demon incarnate and the demon passed through him to trap her.

In some places it is a kindred cult; of all the girls born to a family one of them will belong to the family deity. Before the advent of Christianity, this was not seen as a problem, as the person concerned will not marry but can stay at home and bear children as bastards. In those days people were proud of it but today things have changed because of Christian enlightenment. Though, in countries where voodoo is practiced one still sees women walking naked with only a piece of white clothe around their private parts. This is when the girls or women are being prepared for voodoo priesthood. Any man that has sex with her this period dies after. I am not sure they marry later.

## **Chapter three**

### **HOW DOES ONE KNOW ONE HAS SPIRIT MARRIAGE?**

I watched a Western Movie, called “The Dark Bushido”, and saw one of the ways one can be initiated unawares, even as an adult. In that movie the chief character was in quest of power to deliver his people who were oppressively ruled by a European people. He got in touch with a spirit who claimed he could help if he would make a covenant with him (the spirit). He was to cut his body with his sword and use the blood to write the name of the spirit on it. This he did. He went and fought and won. When he returned, the spirit manifested again to him and told him he was to give his only daughter to him (the spirit) as a wife. He was only to call the girls name and make some enchantment. Then call her on phone, and cut the call when she answers. This he did. That very night, the girl who was in another continent, after receiving her father’s call was pondering why her father behaved that way, had a dream where she was having sex with an unknown man.

I related the above story to let my readers know that some people, in fact a lot of people do not know how they got into this problem, but only noticed some of the signs I am about to discuss here.

**(a) Having sex in the dream:** This is the most common and simplest sign; if one has sex in the dream on regular intervals it’s a sure indication that one is involved in spirit marriage. Some people know the spirit sex partner.

**(b) Spirit visit in a physical form:** In the case of Emmanuel Eni (read the book “Delivered from the Power of Darkness”) a spirit woman visited him, his neighbors would see her but only Eni knew that woman was the “Queen of the Coast”. A woman that was delivered under my ministry will have a visit from a snake. Every other person will see a snake but the woman knew better. She said that this snake used to have sex with her. In fact there was another lady God used us to set free. This one became insane before her people knew what was happening. At times the visit is spiritual in broad daylight; you see that one talking to somebody you cannot see.

**(c) Having children in the dream:** Some women, on the physical are not married or may have even married but no pregnancy. But at times will be having feelings common to pregnant women. Then she will deliver in the spirit underworld, most times in the underwater world of demons.

**(d) Demonic blockade to breakthrough.** There are women who do not have this problem consistently but when a man approaches them for marriage they either become ill, act insane or develop some abnormal disposition. Immediately the man departs, she will regain consciousness.

Some men when they decide to approach a woman for marriage, their source of income will begin to suffer set back until the marriage crumbles.

There was a man who had this problem but because he was born again, the spirit wife was finding it difficult to control him or his marriage. Along the way, I do not know what happened but they began to succeed to torment his wife each time the man attempted to have sex with his wife. They did not stand together against the spirit but began to accuse each other and one day the man just dropped dead. That is why I recommend that people wishing to go into marriage should visit a deliverance ministry as part of their plans. This will help to forestall some of the painful experiences young couples go through as a result of spirit husband/wife attacks.

**(e) When you see yourself involved in a wedding in the dream;** some women tell of this happening when they were still too young to marry physically. As they begin to grow up the spirit husband begin to manifest, at times sending them gifts. People see these gifts but don't know the origin. The demons at times take them to the home in the sea or deep forest. Such victims wake up in the morning exhausted and tired.

### **WHY BORDER YOURSELF?**

Whereas witches are the most evil of devil's kingdom (that is if evil have degrees), the spirit husband/wife is the most stubborn.

- (a) It is very difficult for somebody bound in spirit marriage to be able to marry physically.
- (b) In a situation he/she marries, the spirit marriage partners fight with the last ounce of energy to make sure that one regrets it. It sets in sickness, diseases, insanity, and poverty of the terrible and unbearable kind.
- (c) The human life partner of the person bound in spirit marriage is in worse danger because the spirit husband/wife will try to kill the person if he fails to stop the marriage. Many young women had died before or immediately after their marriage and people brand them "Ogbanje" (underworld spirit cult that young women commonly belong to; under which they have a covenant to die premature after causing their loved ones pain), not knowing it was the spirit wife of their husband that attacked. Some men had lost their businesses or their job immediately after or before their marriage not knowing it is the spirit husband of their wives that is fighting.
- (d) Unless Pastors and Christian people understand this evil phenomenon they can do little to help people with this problem. I have heard people tell of how many places they have gone for deliverance but solution eluded them, simply because the ministers do not understand the problem. Immediately one confesses he or she had attacks in the

dreams many Pastors start laying hands hoping that the demons would go but we discover that after a time our client comes back complaining of the same thing.

(e) Spirit husband/wife came in by a covenant and handling covenant problems is not always easy.

## **Chapter four**

### **HOW TO PREPARE FOR DELIVERANCE**

**Prepare your mind:** - Once it has been proved that one has this problem, he/she should be encouraged to brace-up for a long battle. Spirit husband/wife is a stubborn case that is won only by persistence and patience.

**Open up:** - The client should open up to all that needs to know.

- (i) The marriage partner should be told so that he or she will prepare his or her mind.
- (ii) The Pastor of the client that is if the person is just visiting a deliverance ministry. It is wonderful if you have a humble man of God for a pastor who seeing he cannot handle the case alone, escorts you to another minister and then join hands to pray for the client.
- (iii) The client should tell the deliverance minister all that he/she knows or any clue that will help him understand the covenant grounds of the demon. I say again that the deliverance hall is not a place for secrecy. Devil deals in secret because he is darkness. Once you come into light, he flees. At times the legal ground is a secret sin you got into, like sister Regal. The only way to violate it is to confess and turn from it. (Prov. 28:13)

**Give your life to Christ:** - It is shameful to state that some deliverance ministers pray for people without guiding them to the way of salvation. And there are people who come to be delivered without wanting to make a heart commitment to Christ. To give your life to Christ is not just to repeat a few words after your Pastor and return to your shameful ways. To give your life to Christ is to repent and turn from every appearance of sin.

A girl came to see us over the problem of spirit husband, which have hindered her from marriage for years but would not quit an illicit relationship with another woman's husband. Another is living with a man that has not paid her dowry; she wants deliverance but will not cease from that relationship. The deliverance minister should not waste his time with such people. Devil could use them to harm you.

***But when people keep on sinning, it shows that they belong to the devil, who has been sinning since the beginning. But the Son of God came to destroy the works of the devil. 1 John 3:8 NLT***

The person deliberately keeping to willful sin is devil's property and it is wrong to try to deprive the devil of his property.

## **Legal Grounds**

What do I mean by legal grounds? Let's take for example a man who packed into a rented property and paid part or full payment for it; the landlord discovers after a while that he did not like the tenant. He cannot just force that tenant out without following due legal processes because in accepting part or full payment from him they had a contract. But on the contrary if the tenant just forced himself into the property without due process, he does not have a legal ground to be there; the landlord can also throw him out without resort to the law court. In the same way, demons that entered people's lives without getting the consent of the person and when the person did not deliberately get into sin, can be forced out by a mere rebuke. Unfortunately spirit marriage is often a covenant case; hence, we need to violate the legal grounds before we can have a lasting positive result. The account I gave earlier on a movie, the demon passed through the legal grounds a father has over his daughter. In the oriental culture of China, the words of a father are final as long as the unmarried girl is concerned. If the lady in question were a believer the Holy Spirit would have resisted the transaction because she is under higher authority because the bible says, she belongs to Christ. Many believers do not know the privileges they are enjoying by belonging to Jesus Christ. A shrine or altar dedicated to the worship of the spirit is a legal ground and so must be destroyed if the deliverance must be effective.

***But he who unites himself with the Lord is one with him in spirit. ....Do you not know that your body is a temple of the Holy Spirit, who is in you, whom you have received from God? You are not your own; you were bought at a price. Therefore honor God with your body. 1 Cor 6:17, 19-20 NIV***

## **Open Doors**

Open doors are careless ways through which the demons can enter the life of persons or believers who dropped their spiritual guard. It could be by allowing your anger to last more than normal or allowing thoughts of unbelief to linger in your mind, etc. I saw in a man's house a symbol of a secret cult; the man saw it in a friend's house and asked to have it. He was ignorantly innocent but such things can serve to open doors to evil spirits. Some while living with a relation had helped to serve a particular spirit by going on errands and standing by to affirm prayers to the demons. The mischievous demons gain access through that means.

Deliverance questioner is a wonderful tool we invented to help the client remember almost everything that need to be exposed. It is available in our office. More about this can also be found in my book, "How to be Delivered and Remain Delivered".

## Chapter five

### DELIVERANCE PROPER

After you have opened up to your life partner, Pastor and deliverance minister, the enemy has lost strong grounds. If the client had sinned, the offended party should immediately in the mind of Christ forgive. We have instances where some spouses refuse to forgive. They say, "So God is punishing you because you have been cheating on me?" Some even become afraid and say, "So I have been living with a demonic agent in the house". There was even a case of a man who said of the wife, "You are so wicked, you have given birth to five children for that demon and you refuse to give me even one". Spirit children are not there at all. It is part of Satan's deceit to make people believe what is not true.

They should hold hands together and pray in the spirit of agreement. The parties involved must remain united in the fight and see Satan and his demons as a common enemy.

Example:-

***Father we thank you for your son Jesus Christ for his sacrificial death on the cross of Calvary and the blood that was shed for our sister/brother. We stand as a Church to forgive her/him of whatever sin. For the bible says that whoever we forgive is forgiven. We also lift the covenant in the blood of Jesus Christ as a banner over any other old covenant with spirit husband/wife and the bible says whatever we decree her on earth will be done for us by our father in heaven. We therefore decree that this spirit marriage is a pervasion of the law of God. We declare it null and void. We break the bonds and ties that bind our sister/brother in this marriage.***

***Though, a lawful captive, the bible says that the Lord shall set free the lawful captive and the prey of the fierce shall be taken away (Isaiah49:24-26). We set her free today in the powerful name of Jesus Christ. Amen.***

If the client is married, the marriage partner of the client should pray first before this.

*Most loving and eternal father, I thank you for our salvation and the precious blood of Jesus Christ that redeemed us. I stand on the authority of the word of God that says, "Whatever God has bound together, let no man put asunder" to declare that ----- (her name) is my lawfully wedded wife according to the law of marriage on earth and in the church. Hence, this evil spirit is trespassing an institution you established. Therefore I declare that the spirit marriage*

*between ----- (her name) and this demon is unlawful. I, the legal husband therefore command this demon to get out of her life now, in Jesus Name. I declare the terms of this evil marriage null and void, in Jesus Name. I agree with pastor ----- (name of your pastor or deliverance minister) as we drive you out of this life in Jesus Name.*

I have only given a prayer model. You can add or take away from it. As the prayer goes on, the evil spirit or contact demon in the client is bound to manifest. That is why the brethren should be prepared to carry on deliverance immediately. An all night prayers should then be organized and the client prayed for extensively. In my ministry we organize a deliverance night and the client is ministered to.

Some ministries tell the client to go into long fasting before the deliverance. I would say that we should be guided by the Holy Spirit in this matter. And the fast must not be too long as it may grant the evil spirits a greater access to the soul. Six-to-six for seven days should be the maximum. We also give out prayer topics like the ones attached at the last chapter of this book; the client is advised to pray them over for seven nights. Deliverance can come faster through this path.

I would say that the preparation in the area of fasting in this case is for the deliverance ministers. The bible says that some demons do not go unless through praying and fasting (Mark9:28-29). I believe the spirit husband is one of such. Another reason this is important is that spirit husband/wife usually fights back. If the team is not well prepared, they could suffer casualty.

Even Jesus prepared himself through an all night prayer for his daily ministry engagement. It is unfortunate that some ministers would rather attend ministers meeting, visit the Governor for contracts and pursue visa for U.S.A. When such challenges arise, there is then no “oil” to minister with. They now resort to olive oil. They pour it all over the client, making her to drink it.

I am not against olive oil but if there is no power in you, a drum of olive oil makes no difference. The minister should also understand that the spirit husband/wife is a living being and a covenant spirit. Be sure you do not leave any spiritual door open as you fight.

The client on his/her own part should ask God for guidance as to where he/she goes to for deliverance. Many Satanists know now that people are no longer willing to patronize them so they masquerade as spiritual warfare ministers. The common denominators for this ones is that they ask you to pay for this and that, buy spiritual oil from Jerusalem, pay for anti-evil attack soap, oil and all manner of salt. Not many of them burn incense and candles

openly these days. The reason where you go is important, is that a Satanist will worsen your problem.

Please let me point out that there are ministers who may be practicing these things we condemn but are not necessarily bad people; they just copy anything they see other ministers practice. I advise men of God to thoroughly check the biblical soundness of some prophetic actions before they borrow them. Today, many go to Jerusalem to buy special oil, salt and even sand. This is how some dabble into occult unknowingly. If your deliverance will come it is not likely to be from today's Jerusalem because the bible says that she and her children are in bondage. There is a spiritual Jerusalem to which every believer belongs through Christ Jesus. That heavenly Jerusalem should be your source of power. (Gal.4:25-26).

### **Break the Covenants and Destroy the Shrines and Satanic Altars**

In some cases the client has a shrine or altar dedicated to the spirit husband/wife. I suggest that the client should be baptized first before he/she is taken before the altar and made to renounce the covenant that established the altar. Let me say that the client and the minister need not fear any evil. God is standing by you any time you undertake such holy venture. There was the account of some ministers who ran away when they saw a live snake in the house built for the demon. This is sheer ignorance. If it is something like a snake and you don't want to go near it, pour kerosene all over the place. Kerosene kills snakes; use knives or gun to kill dogs and other wild animals.

At times you feel a current of fear all over you; it is the devil trying to make you afraid. Don't fear; stand your ground on the authority of God's word which has declared the victory of light over darkness. The child of God is light and so darkness has no choice but to give way. This is the main reason I suggest that the client should be baptized before confronting the altars. Some churches advocate baptismal class before baptism. I have problem with some pastors over this; I am a deliverance minister and my assignment is not to follow some church doctrine. I do everything biblically right to set the captive free. Again there is no bible example where people were passed through baptismal class before baptism. The client and the deliverance minister should understand that the task before them is different from the pastor's task. If you find that the pastor of the client is the kind that does not believe in deliverance, please go ahead and save the client from the devil's hold.

Before the shrine or altar, the client should be guided to say the following prayer- ***By the authority in the name of Jesus Christ; I stand on the authority in the word of God and renounce you----- (name of the spirit). The covenant between you and me is hereby broken because I have found another Lord over my life whose name is Jesus Christ. I cease to***

***serve you or belong to you. I renounce and reject you in the powerful name of Jesus Christ.***

***I permit this servant(s) of God to destroy this altar and set it ablaze. I declare that the terms of curses connected to the covenant I had with you will not affect me or any human being in Jesus Name.***

The minister may pray like this- ***Having renounced and rejected you--- (name of demon), I exercise my authority as a servant of God to free this child of God from your control. The bible says that by her words she shall be condemned and by her words she shall be acquitted. She has publicly renounced you and has been brought into a living covenant with Jesus Christ. I command that you leave here now and to follow her no more in Jesus' mighty name!***

I wish to repeat that the prayers must not be my exact words. But stand your ground. I have testimonies of those who did not consult any minister but burnt down their shrine and nothing happened to them.

In a situation there is no physical shrine or altar, prayers can still be made.

### **They will drive out demons**

Now that you have destroyed the material altar it is time to deal with the spirits. Spirit husband/wife is a demon, so cast it out according to the words of Jesus Christ

***And these signs will accompany those who believe: In my name they will drive out demons Mark 16:17 NIV***

***He replied, "I saw Satan fall like lightning from heaven. I have given you authority to trample on snakes and scorpions and to overcome all the power of the enemy; nothing will harm you. Luke 10:18-19 NIV***

After warm praise and worship session you can begin to address these demons to get out. Initially you may not notice anything, but as you continue to address the spirits, there will be manifestation. Those who know the names of the demons harassing them have an advantage. It is better for the client to be ministered to by a prayer group. In the midst of prayer ministrations I have seen many evil spirits leave. You can also minister to your loved one if you're a spirit filled believer. Even if you don't see the demon, stand on the word of God and with the support of the Holy Spirit the demons will obey your command. At times the client will start point to a direction and cry, "See they are coming!" Don't be distracted by that; once the demons in her leave she will not see them anymore. Remember to destroy through prayer all the gadgets they have in her that enable her to relate with them. In this way they can't keep in touch with her.

The two scriptures mentioned above can always be referred to as your authority. Remember to repeat the name of Jesus Christ several times because the bible says that at the mention of that name every knee must bow. That includes the knees of demons.

***Therefore God exalted him to the highest place and gave him the name that is above every name, that at the name of Jesus every knee should bow, in heaven and on earth and under the earth, and every tongue confess that Jesus Christ is Lord, to the glory of God the Father. Phil 2:9-11 NIV***

## **Chapter six**

### **AFTER DELIVERNACE**

I have seen people who run to their centre of sin immediately or sometime after deliverance; they say, “I am going for deliverance now so I will not fornicate, drink alcohol etc. After my deliverance process is over I will continue”. Jesus says that after an evil spirit has been driven out of a man it will return to see the state of the man (*Luke 11:24-26*). And the spirit husband/wife is sure to do that. You will be harming yourself if you do things that will grant him re-entrance.

- (a) Be filled with the Holy Spirit. Yes, when evil spirit is driven out of a person, the client should be prayed for to be filled with the Holy Spirit. When the Holy Spirit takes over the space left by the demons, the client will find it easier to resist the things that can grant access to the demons. He will also be able to remain in prayer and to challenge the evil spirit on his own. When my younger sister was delivered from python spirit, the demons returned when she came back home. It was a great battle but she won because she was taught how to fight back. Victory over Satan and his demons is near impossible without the infilling of the Holy Spirit.

After every deliverance prayer session the client should ask the Holy Spirit to fill him afresh; there is room for a fresh infilling every day. The minister should also pray that the clients be filled with the Holy Spirit.

- (b) The client should remain in fellowship with the deliverance ministry for a considerable time. Within this time he/she and other people with similar problems, where possible are trained to help others. In this matter of spirit husband/wife as in witchcraft, those who have suffered are in a better place to help. Sorry to state that most people who have not gone through this affliction are “spanners in the work”.
- (c) The client should not believe the devil. The devil is a liar, as well as all demons. I have heard clients tell me that the spirit husband/wife had threatened to come back after and torment the clients. Some say they are waiting for the client at home. The deliverance minister has a duty to make the client discover what the bible, which is the word of God, says and convinced to believe it. They should also be made to know that those demons will obey their command as they obey the command of the deliverance minister. Demons don't obey titles but the authority we have as children of God.
- (d) The client should be made to understand these three elements that work together for a successful, total deliverance. None is dispensable.

Hope (God's will for you), faith and patience. What I mean is that there are physically things the spirit husband/wife deprived our client. For example, fruit of the womb, life partner, prosperity, I mean external material things. The client should rejoice in his new deliverance and new found peace of mind rather than set his/her mind on those things as whether they are coming or not. They may take sometime to manifest.

The things that must be taken care of immediately are the yoke of anxiety, fear, having sex in the dream, visit of the demon, insanity, etc. The physical person will take a little time to recover. Inability to understand this has made clients to run from place to place and hence prayers are ineffective.

- (e) If prayers are not answered in one way or the other, open doors should be re-examined and prayers continued. Most deliverance ministers due to impatience and principally ignorance are always in a haste to move on. That is why churches and Christian ministries should start to train members, so that the work will not be too much for the Senior Pastor. In a deliverance ministry everybody should be trained to minister deliverance.

I wish to let clients know one principal reason why deliverance ministers would not want to waste so much time on him/her. Most people are willing to pay huge bills to doctors but find it difficult to give anything to prayer warriors. There was a case where a lady who was struck mad was referred to me by a doctor after collecting his bill. It is shameful to say that after God restored this lady under our ministry through the teamwork of our members, the man (the uncle to the client) a professing believer gave us Five Hundred Naira, took the girl and promised to come back. It is now more than seven years. I have not seen him. There was a case of the lady, who had spent Seventeen Thousand Naira in a futile effort to get deliverance, but God delivered her under our ministry, she did not give as much as ten Naira to our team.

It is a pity Satan often used clients to discourage deliverance ministers or force them to begin to charge money, which is against God's will. The last resort is that the team scatters as people would want to work to earn their living. Where you can, encourage these men and women to stay together. We need them one time or another.

## **Chapter seven**

### **THINGS THAT MUST NOT BE DONE AS YOU SEEK DELIVERANCE**

Do not visit native doctors, white garment churches, Indian magic etc. They all promise you freedom but land you in greater bondage. “Buy a white cloth and a goat, bring money to buy some spiritual materials and I will appease the spirits”. Some women said they cut their hairs and pubic hairs, take them to the stream and bathe them. Some kill goat and bury the head with the cloth while some bury the goat alive. All such things are done but ask those who were there before and they will tell you that they never work at last. The only way to get deliverance from Satan is by the power in the name of Jesus Christ. It may seem as if all hope is lost but stick to Jesus Christ. He will not disappoint you. I saw that in my wife’s case. My mother-in-law and some other women suggested to her to secretly visit a “Mummy water” agent or native doctors that are reputed for delivering people. She refused and today she is okay. Praise God! Stick to Jesus, he will set you free.

Do not permit unbiblical things. Some women were asked to make sex with the false pastors or other men, as “Heaven helps those who help themselves”. This is the devil’s lie. Anti-evil attack soap, cream and everything that the bible condemns cannot help you. Do not disobey God. Again I lament that a lot of Satan’s agents now parade as deliverance ministers, but God will guide you.

Do not visit two deliverance ministries at the same time unless the minister in-charge permits so, in which case one does counseling and the other prayers. Do not ever try to deceive your minister. You will harm yourself. If you worship in a living church that lacks a balanced knowledge of deliverance, then let your deliverance minister know, he will tell you what to do.

### **Medium and Diviners Masquerading as Deliverance Ministers**

There is a lot of what used to be condemned among believers coming up now among deliverance ministers these days. They rarely open the bible and recommend the same things witch doctors recommend; red cloth to bury in the cemetery, calling up the spirit of dead people to speak through one of their workers, extracting iron, needles, broom sticks from people’s bodies. All these are lies and deceit of the devil. If you have material like iron in your body you would be feeling it before you come to the minister. Those things are conjured into your body by the false prophet. Some call down fire and eggs. Remember that some of these people used to stand by roadsides as Indian magicians conjuring biscuits and sweets into cartons; now they operate as

false deliverance ministers. No matter your challenges make up your mind to follow only the leading of the Holy Spirit and He will guide you. Take note whether the minister is trying to promote his great power or promoting Jesus Christ; note also whether he will end up asking you for money to buy mystic materials. This is different from asking for money for the upkeep of his team.

## **Chapter eight**

### **WHAT DO I DO IF PROBLEM LINGERS?**

We need to face the reality that at times we don't get a very fast result in our search for deliverance. That is why I encourage the person in search of deliverance to follow very clear rules and obey instructions. In this way it will be easy to understand complicated issues. If the client does not follow instructions or deliberately disobey instructions, we won't be able to understand why the challenges persist. Imagine somebody who lies that she is duly married to the man she is living with when the opposite is the case. The spirit husband is claiming it is married to her under a covenant and the human husband is only a "boyfriend" who repeats the prayers I mentioned earlier; how do we deliver such person?

In some cases, some religious people will say I came here for deliverance, don't raise questions about my denomination, but how if her denominational conviction is a barrier to her deliverance? Some refuse to be baptized by immersion; they don't see how their immersion baptism is connected to their total deliverance. I keep repeating that baptism by immersion was not intended to be a religious ritual; it is initiation into Christ and covenant grounds in Christ Jesus which can cancel other ungodly covenants when it is properly done. I dealt with this more clearly in my book on Doctrine of Baptisms.

There are also those who are willing to gossip their problem everywhere but when it comes to action, you hear them begin to give excuses like, "You know the nature of my job; it won't permit me to be in fellowship". Some even pay people to fast for them. Yet, others say that their social class won't permit them to join prayers in some places. All these are baseless arguments which only help to keep them in bondage.

When deliverance is delayed or unsuccessful, the first thing to do is to carry out a check on yourself and the way you have been going about the deliverance process. After checking yourself, you then check the minister and ministry guiding you in the deliverance process.

Demons are easy to handle if you are determined. It may take time, but Jesus Christ has won the victory already for us through his death on the cross. Stay connected to Christ and the Holy Spirit will help you. I have seen people who took their lives in their hands, went into long and aggressive fasting and prayers, confessing and claiming the promises of God and then their problem disappeared. I believe that every client reading this book will have total victory in Jesus Name.

Note also that some problems that appear spiritual are actually medical. For example, syphilis has a stage where one feels moving objects in the body or as if ants are creeping over ones face. A woman, who was complaining of barrenness as a result of spirit husband, later discovered when my wife sent her and her husband to a medical laboratory that her husband had zero sperm count (no living sperm in his semen). My wife and I combine medical and spiritual methods. The deliverance minister should be guided by the Holy Spirit.

### **How Are You Sure It Is Spirit Husband/wife?**

This is a question I have asked some clients. That you have sex in the dream may not automatically imply that it is spirit marriage. At a particular age the hormones in the human body develop and this creates sexual urge. This message is relayed to the organs in the body. This can lead to wetting oneself with sperms in men. When these sperms are released the man is likely to see himself having sex in the dream. This also manifests in different ways in women.

It is my advice that the client should do a careful study and see the consistence of the sex in the dream and back it with other signs that we mentioned as symptoms. If the only proof you have is sex in the dream, it may not be spirit husband. The spirit husband/wife is a demonic personality who wants to be noticed and to be in charge. Some women see some cloths, pants and other under wears which they immediately recognize as gift from their spirit husband. Some get physical jewelries; things that a human lover would give to them. These spirit beings appear to them and discuss with them. They are also very jealous. There are occasions the spirits come threatening the client if he/she wants to go into relationship with a human being.

That one is having problem in keeping relationships may not also translate to spirit marriage. If you have bad manners or are greedy or selfish, your relationships are sure to crumble. No woman wants to keep relationship with a man who does not have vision. If she falls in love with you and later discovers that you don't have vision, she will quit the relationship. It is not likely that a man would want to continue in relationship with a woman who nags or is a fault finder.

Once you are sure it is spirit marriage, then stick to your gun; it will surely bow and you will have your freedom. My wife's case is an example.

## **Chapter nine**

### **HOW DOES A CHURCH (MINISTRY) PREPARE ITSELF FOR DIFFICULT CASES?**

I wish to state that any church; evangelical, Pentecostal, Anglican etc can be useful in this area. In fact the so-called “Prayer Houses” have been able to help some people because they apply the points I want to mention now. Unfortunately modern Pentecostal buildings are different in constitution so they have only “Grammar-Grammar”.

The senior pastor and the pastors should form and become active members of a prayer team that handle deliverance. In our time most senior pastors do not stay in churches anymore. They go from meeting to meeting, from office to office. Many of them will not attend to people except on counseling days and a shame that even on counseling days they are not on seat. But when cases come they jump to the front and even fight anybody manifesting more power than they. This is not supposed to be. So, when people come, we cannot meet their needs. When we do not meet their needs, they go to the wrong places.

Workers should be given a balanced training on counseling. Most churches have no counselors and some, lopsided counselors who are either sounding “spirit-spirit” or “Flesh-flesh”. The counseling ministry is very sensitive. I have seen serious cases taken care of by counseling.

A medical team should be ready to test or direct the client to a trusted laboratory. So that medical cases can be separated from spiritual.

Make the clients know almost at all deliverance meetings that the workers have personal needs, and should be encouraged financially and materially to give time to the work. In some churches, the senior pastor goes home with everything. This is wrong. Even if some of them are working, give them the choice to say “No”.

Do not honour wealthy and educated men who are not anointed above anointed ones who may be materially poor. It generates envy that will kill the ministry. Do not discriminate. Most of Jesus disciples were illiterates, but see what God did with them.

Declare days for deliverance meetings and teaching. Teachings are better done mornings and evenings, and midnights for deliverance proper. Because deliverance takes time, making it a night vigil will make the workers settle down and do the work.

Invite other ministers from other deliverance ministries to minister to your church (ministry) that will help your workers learn new and easier methods for deliverance. But be prayerful about whom you invite, so that strange spirits do not come into your ministry and cause problems.

Fasting and prayers are very crucial for any person or ministry that wishes to be relevant in deliverance and spiritual warfare ministry. Imbibe the culture.

## **Chapter ten**

### **Prayer Topics**

I am giving you this twenty prayer topics which I suggest that for a start you say them for seven consecutive nights between 1am and 2am. If you take these prayers serious you will surely have a good result to share as your testimony. You can also use them for group prayers.

Sing praise and worship for at least ten minutes before embarking on these prayers. Read Ephesians6:10-18 and Philipians2:1-11. There is nothing wrong with reading other scriptures before and after the prayers.

1. Declare over yourself more than ten times, "The Blood of Jesus Christ!"  
I sprinkle the precious blood of Jesus Christ over my Spirit, Soul and Body. I sprinkle the blood of Jesus Christ all around this room. I sprinkle the blood of Jesus Christ over the spirit realm where I am mentioned or represented.
2. Declare, "I renounce every covenant pact between me and any spirit being. I declare it an abomination in the name of Jesus Christ.
3. By the power in the blood of Jesus Christ I confess and renounce every sin that would have opened doors to this pact in the name of Jesus Christ.
4. (If you were sold by somebody else into the marriage then pray this way)  
I declare that this covenant did not get my consent; others spoke for me when I could not speak for myself. I stand now to declare that I do not agree with the terms of this covenant, in the Name of Jesus Christ.
5. I renounce this ungodly covenant, the terms thereof, and the demons that supervise them in the name of Jesus Christ.
6. By the covenant I have with Christ through my confession of his name, my baptism into his name and my outward declaration of my faith in his name, I separate myself from the abominable covenant with demons and stand firm in my covenant with Jesus Christ in Jesus Name.
7. Declare "Holy Ghost fire!" seven times and pray, "I command that the fire of the Holy Spirit destroy all demons in my body and around me in Jesus Name. (Say this prayer more than two times).
8. Declare, "You evil spirit in my body, I command you to come out now, in the name of Jesus Christ! (Pray this also several times. There may be manifestations but don't fear because God is in control).

9. Declare, "I command that every object in my body that is a token of this covenant be destroyed by fire. I cast them out now in Jesus Name!" (Pray this prayer several times also).
10. I renounce all properties in the spirit realm that I am connected to, in Jesus name! I renounce every ring, jewelries, clothes, cars, thrones and whatever else linked to me, in Jesus Name! (Repeat several times).
11. I renounce all cults like "Ogbanje" through which I am linked to this spirit. I break every tie I have with them in Jesus Name!
12. I renounce every spirit name I have with the powers attached to that name and titles in Jesus Name! (Some have names that they are called in the spirit).
13. I renounce and terminate every time-table and season set for me to die, suffer or appear in the demonic world. I declare that my soul and body shall no longer respond to that time and season in Jesus Name! My body organs shall no longer yield to the command of any demonic authority in Jesus Name! (Most time clients don't know when and how they find themselves under the command of those demons. That is why you have to repeat this prayer several times).
14. I command that fire devour all spirit children and friends linked to me in Jesus Name.
15. I declare that they shall no longer have access to my dreams and revelations. I command that fire destroy whatever they have in my eyes and ears that enable me to see or hear them in Jesus Name! (With your hands on your eye and ear repeat this prayer several times).
16. Declare Holy Ghost Fire 7x and pray, "I command that the fire of the Holy Ghost destroy now every monitoring device used to monitor me, in Jesus Name! I destroy the mirrors and crystals in Jesus Name!"
17. I command that every monitoring spirit sent to monitor me become blind and lose every contact to me in Jesus name!
18. I immerse my spirit, soul, and body in the ocean of the blood of Jesus Christ! (Declare the blood of Jesus Christ several times).
19. (Cup your hand or take a cup of water as much as you can finish once) I declare through faith that what I have in my hand is the blood of Jesus Christ, as I drink it now I am drinking the blood of Jesus Christ and by taking this precious blood I destroy the power of whatever I

would have eaten before now and purge myself of every evil presence and contamination in Jesus Name!

20. I open myself up to the infilling of the Holy Spirit and declare, "Holy Spirit fill me now, in the name of Jesus Christ!" (Repeat this several times and be still in God's presence).

You can begin to thank God for your deliverance in every way you can.
